

**- NON-EXCLUSIVE - PERSONAL USE MUSIC LICENSE -**

This is a license agreement made on, or after April 3rd, 2015, by and between **JAMES M. KULAKOWSKI**, the '**LICENSOR**', and YOU, the '**LICENSEE**', bound to the following recordings, hereafter referred to as '**MUSIC**':

**Polycephaly**

By paying the fee outlined in section **11** of this document, and by incorporating **MUSIC** within it's products, **LICENSEE** agrees to be bound to the terms of the **end user license** (EULA) herein, which are as follows:

**1) TERM:** This license is valid for perpetuity.

**2) UNLIMITED TERRITORY:** The license is valid for any territory throughout the world.

**3) USAGE:** **LICENSEE** is granted the right to incorporate, or embed, **MUSIC** into **NEW MEDIA** for personal use only. For the purpose of this agreement, **NEW MEDIA** is defined as: any new product in which **MUSIC** is embed, in part, or in whole. **LICENSEE** may embed unlimited copies of **MUSIC** within **NEW MEDIA** that does not generate revenue for the **LICENSEE** and/or it's business partners.

Examples of **NEW MEDIA** include, but are not limited to DVDs, e-learning tools, mobile apps, multimedia CD-ROMs, podcasts, slideshows, social media video, streaming video, student films, video games, Vimeo videos, website background music, wedding videos, Youtube videos.

**4) USAGE LIMITATIONS:** This license does **NOT** include usage rights for any commercial use. **LICENSEE** may only share **NEW MEDIA** in which **MUSIC** is embed with non-paying parties. Music may not be embed in any product that gains revenue for itself, or via paid advertisements. Examples of revenue-generating **NEW MEDIA** include, but are not limited to, feature film use, internet/online advertisements, radio/television advertisements, television broadcasts, or any other form of advertisement. Additionally, mobile apps/games being provided under the "freemium" model (apps/games that generate revenue for **LICENSEE** via in-app purchases and advertisements) are considered commercial uses are not permitted via this license. **MUSIC** may not be used in musical works, or **NEW MEDIA** where a derivative musical product has been created using **MUSIC**.

**LICENSEE** may not sell, resell, re-license, sub-license, give away, or make **MUSIC** available to any audience, without being incorporated into a new product. Moreover, **LICENSEE** may not sell musical Polycephaly without a specific "mechanical" license, which may be negotiated by contacting the **LICENSOR** (Contact information listed below). **MUSIC** may not be incorporated into videos or other media where it is the main feature. For example, syncing the **MUSIC** with it's title and a moving background/image, then uploading the compiled video to Youtube, Vimeo, or any other online video site is strictly prohibited.

**5) NON-TRANSFERABLE:** This license may only be held by the original purchasing party. It may not be sold or given to a third party,

**6) COPYRIGHT/OWNERSHIP:** **LICENSOR** will retain all right, title, and privilege of **MUSIC**. Upon creation **MUSIC** is copywrited and governed by the copyright laws of the United States Of America. **MUSIC** is also registered and protected by Broadcast Music Incorporated. **LICENSOR** provides this license in order to grant certain rights, outlined herein, to the **LICENSEE** pertaining to the personal use of the **MUSIC**.

**7) NON-EXCLUSIVE:** This license is non-exclusive and **MUSIC** will be made available to 3rd parties for incorporation with other media.

**8) ATTRIBUTION:** Written credit must be provided as "Music by Jim Kulakowski" or, "Score by Jim Kulakowski", where applicable - in app credits, DVD credits, toy/product packaging, etc.

**9) PERFORMANCE ROYALTIES:** **MUSIC** will be filed and registered with Broadcasting Music Inc. (BMI), and public performance royalties will be due where applicable. Examples of applicable instances are as follows: Plays on terrestrial and satellite radio, usages on network and cable television, plays on internet radio, and plays on online music streaming services (Spotify, Pandora, etc.). **LICENSEE** must file a cue sheet with the broadcasting channel in which **MUSIC** is being aired. The completed cue sheet must also be returned to the **LICENSOR** within 10 days April 3rd, 2015 the date the **MUSIC** is broadcast.

The total liability of **LICENSOR** under this agreement shall be limited to the **Fee** paid hereunder by **LICENSEE** to **LICENSOR** for the license. **LICENSEE** hereby agrees that this license is granted without any other warranty or recourse.

**13) TAXES:** License Fees are exclusive of any applicable sales, use, withholding or other transactional taxes, which are the sole responsibility of the **LICENSEE**.
